

NOTICE OF APPLICATION FOR CONSENT
pursuant to Ontario Regulation No. 197/96, as amended

TAKE NOTICE that the Southeast Parry Sound District Planning Board will be considering applications for consent under Section 53 of the Planning Act (**File No. B-049/21 & B-050/21**).

THE PURPOSE AND EFFECT of the proposed consents is to create two new lots for residential purposes.

THE SUBJECT LANDS ARE LOCATED in Part of Lot 6, Concession 10 within the Township of Ryerson, as shown on the attached map(s). Severed Lot #1 (B-049/21) will have an approximate frontage of 150 m. (492.13 ft) on Hill & Gully Road and 100 m. (328.08 ft.) on Pete's Hill Road, an approximate depth of 235 m. (771 ft.), an approximate area of 2.4 ha. (5.93 ac.) and is presently vacant. Severed Lot #2 (B-050/21) will have an approximate frontage of 120 m. (393.7 ft) on Pete's Hill Road, an approximate depth of 235 m. (771 ft.), an approximate area of 2.8 ha. (6.92 ac.) and is vacant. The parcel to be retained will have an approximate frontage of 615 m. (2,017.7 ft.) on Pete's Hill Road, an approximate area of 35 ha. (86.49 ac.) and is also vacant.

If a person or public body that files an appeal of the decision of the Southeast Parry Sound District Planning Board in respect of the proposed consent does not make written submissions to the Planning Board before it gives or refuses to give a provisional consent, the Ontario Land Tribunal (OLT) (formerly Local Planning Appeal Tribunal (LPAT)) may dismiss the appeal.
