**Recommendation**: For Council to receive this report for informational purposes.

<u>Purpose/Background:</u> A number of years ago the CEMC at the time suggested to the Tri Council Armour, Burk's Falls and Ryerson, that each Municipality should establish a policy on the use of sandbags, because it should not be the responsibility of the municipality to provide them to ratepayers. Along with the municipality's stock of empty sandbags there was also the issue of filling, delivering and placement of the sandbags. The township's involvement beyond providing the empty bags and use at your own risk sand could potentially lead into litigation against the municipality.

A sandbag policy was adopted by our Council and we now keep a store of empty sandbags in inventory that can be purchased by residents to assist with flood protection and a stockpile of sand is available to fill the sandbags for the convenience of ratepayers.

To date this policy is still good for the township to have in place. Staff reviews and revises the policy every year to keep it up to date.

# TOWNSHIP OF RYERSON SAND BAG POLICY (PUBLIC)

There is no statutory requirement for the Township to provide sandbags, nor to prevent a property from flooding.

Our policy for sandbags is to **assist** with the prevention of property flooding by supplying a **minimal number** of sandbags to individual property owners.

**Property owners are responsible for protecting their own property** and therefore should make their own arrangements to protect their properties, making plans in advance of a flooding event.

Sandbags will not totally prevent floodwater encroaching into property and all owners should remove articles to a safe location above anticipated flood level. People building flood defences with sandbags should also be aware of the building methods to employ in order to make an effective seal and the health and safety implication of manual handling sandbags, as they are exceptionally heavy.

The Township has a small stock of sandbags, primarily to assist in preventing flooding of the roads.

Although it is not the responsibility of the municipality to provide property owners with sand bags, in case of flooding or danger of flooding, the Township of Ryerson does have a limited number of sand bags available to property owners in the Township.

A property owner may purchase up to ten (10) empty sand bags at a cost of \$0.60 (including HST) per sand bag.

Sand Bags may be purchased during office hours 8:30 a.m. – 4:00 p.m.

In an emergency, sand bags can be picked up at the municipal garage after hours from a staff member of the road department. The cost of the sand bags will be invoiced subsequently, from the office.

The Township will have a small supply of sand (without salt) at the Township yard. Sand for up to ten (10) sand bags may be provided (with permission from municipal staff and if sufficient quantity of sand is in stock) and may be taken from the municipal sand pile at no cost to Ryerson Township property owners. (Bring your own shovel).

The Township has made arrangements with Derrick Johnston Construction (in Sundridge) for larger quantities of sand to be delivered to a property owner, at

the property owner's cost. Contact municipal staff to make these arrangements.

**Recommendation**: That Council approve the Release of Tax Assessment Information Policy.

<u>Purpose/Background</u>: As Council is very much aware, the Township of Ryerson must ensure that when it provides any information to the public that it be in compliance with the Municipal Freedom of Information and Protection of Privacy Act. The Purpose of the Act is outlined as follows:

The purposes of this Act are,

- (a) to provide a right of access to information under the control of institutions in accordance with the principles that,
  - (i) information should be available to the public,
  - (ii) necessary exemptions from the right of access should be limited, and specific, and
  - (iii) decisions on the disclosure of information should be reviewed independently of the institution controlling the information; and
- (b) to protect the privacy of individuals with respect to personal information about themselves held by institutions and to provide individuals with a right of access to that information. R.S.O. 1990, c. M.56, s. 1.

After reviewing policies and the Appeal to the Information and Privacy Commissioner with respect to an incident in the Township of Minden Hills, I am of the opinion that the Township should be proactive and develop a Release of Tax Assessment Information Policy which outlines how such information may be obtained by the public.

It is my recommendation that Council pass the Release of Tax Information Policy attached to the resolution as Schedule 'A'.

# Township of Ryerson Schedule "A" to R-\_\_-23 Release of Tax Information Policy

# 1. Purpose

The purpose of this Release of Tax Information Policy is to establish guidelines for providing access to the public of information available in the Township of Ryerson Assessment Roll, while providing protection of privacy respecting government held personal information. (MFIPPA)

# 2. Procedure

**2.1** A member of the public may view the Tax Assessment Roll for the Township of Ryerson.

The information provided in the Assessment Roll is as follows:

- Owner name and address
- Roll Number
- Legal Description
- Assessment
- RTC/RTQ Classification
- 2.2 The Tax Assessment Roll for the Township of Ryerson may not be photocopied.
- **2.3** The Tax Assessment Roll for the Township of Ryerson may not be reproduced by means of a scanner.
- **2.4** The Tax Assessment Roll for the Township of Ryerson may not be reproduced by means of a camera.
- **2.5** Staff members are not responsible for the correctness of the Tax Assessment Roll for the Township of Ryerson.
- **2.6** Staff will not provide any information additional to the Tax Assessment Roll for the Township of Ryerson
- **2.7** Personal information contained in the Tax Assessment Roll for the Township of Ryerson will not be provided by staff by phone. Property information only will be provided
- **2.8** The tax status of a property in the Township of Ryerson will not be released by staff without the written consent of the property owner or their legal representative

# Summary:

The appellant made a request to the Township of Minden Hills for access to the township's tax assessment roll. The appellant wished to examine the roll and scan it using a hand held device. The township denied access under the Municipal Freedom of Information and Protection of Privacy Act, but stated that members of the public may view the roll, subject to certain restrictions. Public access to assessment rolls is mandated by section 39(2) of the Assessment Act. The township denied the request to duplicate the roll by means of scanning or photography. This order upholds the township's decision to deny access under the Act because section 15(a) of the Act applies to the tax assessment roll.








- they are developing maps and training to place on-line

For us- if there was a forest fire, how would we evacuate everyone?

-If people need to be evacuated they need somewhere to go. Host communities can take as many or as few as they feel comfortable helping. There is no cost to the host as expenses are paid. A host community needs a hotel, and be able to meet medical and social needs.

Thunder Bay hosts an average of 2000 evacuees a year. They are well prepared, but they need other communities to help. They will help any willing community set up and plan for evacuees. If a local community is a host, how can we help?

Importance to the Township of Ryerson:

This approach is not used to get your way but to establish a place of mutual respect and purpose. Only when this has been established, can you begin to work on a collaborative outcome where it is a win-win situation for everyone.

Resolving Conflicts become more difficult when parties are fixated on their own positions; emotions are escalating upwards; when we try to solve the problem to quickly; when we fail to find out the WHY behind a person's position.

To solve a problem, we need to:

- 1. De-escalate the intense emotions
- 2. Uncover the interests of all parties (facts, feelings, and identity)
- 3. Now solve the problem

How to approach situations to trigger blue brain responses

- -assess the situation
- -make it safe to talk = establish mutual respect and purpose
- -use words that are more likely to trigger the blue brain
- -ask open ended questions (focus on the words what and how)
- -Loop of Understanding

# LOOPING TECNIOUE

This helps move everyone to a blue brain position. Only once this process is complete can you begin to solve the problem.

- Step 1- you inquire by asking open ended questions
- Step 2 -the other side responds
- Step 3 -you demonstrate your understanding and test with the other side (summarize, paraphrase by giving emotion person felt first and then identity)
- Step 4 -if they confirm your understanding, the loop is complete
  - -if they do not confirm your understanding go back to step one

Knowing my own style, my own general belief system and how I generally react to others, is a necessary part to understanding my reactions to situations. Knowing this information can help me be more aware of situations that might be a red brain trigger or help me recognize if I am in a red brain situation. Once aware I can help m move from the red brain (reactive) to the blue brain (reasoning).

Importance to the Township of Ryerson:

On Tuesday, February 07, 2023, Councillor Abbott, and I took part in a meeting with several of our municipal colleagues from the Almaguin and Muskoka areas and Mike Schreiner to discuss our concerns regarding Bill 23.

Many of the same concerns were shared by the council representatives.

These included,

- the loss of municipal planning tools,
- the inability to protect shorelines, wetlands, lakes, and forest ecosystems without site plan approvals,
- and the possible need to increase tax revenue to cover rising infrastructure costs.

Another point discussed was – why don't we have a protected area like the Greenbelt? We have critical ecosystems in our regions that need to be protected. How do we go about getting this area protected before it is to late.

To discuss solutions to our similar issues, to have a united voice, and to bring our concerns to the attention of the Ford government, it was decided that Almaguin and Muskoka councils would form a working group. As a result, Rod Ward has agreed to help organize this group which will be made up of representatives from each council that chooses to participate from the Almaguin and Muskoka districts.

Dear Councilors Abbott and Patterson,

I know you expressed interest in attending the meeting with your municipal colleagues and Mike Schreiner last week. Unfortunately, freezing rain got in the way of travel plans for some. In spite of that, 5 mayors and 15 councilors from across all regions were able to attend and because of your expressed interest in the event, I am forwarding some of the outcomes.

Concerns shared by elected officials regarding Bill 23, The More Homes Built Faster Act, focused on the loss of municipal planning tools, the inability to protect shorelines, wetlands, lakes and forest ecosystems without site plan approvals and the possible need to increase tax revenue to cover rising infrastructure costs.

As an observer I was particularly interested in one question raised: Why can't we have our own Greenbelt to protect critical spaces here in our regions? Municipalities need more tools to do so.

This question must also be asked: Since municipalities carry the burden of the impact of climate change, including destruction from extreme weather events, fires and flooding, how will we protect the natural infrastructure that protects us and reduce GHG emissions across Almaguin, Muskoka, Parry Sound and Georgian Bay with this "development at all costs" legislation?

Following important conversations in both the morning and in the afternoon those attending decided to form a working group coordinated by Rod Ward, Mayor of Armor Township. They are committed to both bringing concerns to the attention of the Ford government and seeking solutions as a collective voice to the province.

It was a meaningful outcome to a productive day and I am sure they would welcome representation from your township.

Hello again...promise this will be your last email on this for a few days! I want to clarify a few items and, more importantly, clarify some next steps.

- To be clear, I have long been a vocal critic of the hospital build "local share" methodology. I have shared my strong opinions on this with MPPs (Graydon Smith and Norm Miller before him), MAHC, AMO, the Ministry of Health and the media (a link to an article from last year summarizes concerns about the impact of local share to smaller communities such as ours Almaguin health council wants Ford to reexamine municipal share for new hospital builds | The Star )
- Several municipalities in the Almaguin Highlands backed up our opposition to the approach to local share through resolutions in 2022
- There are 2 main points in the message one, that it is simply not feasible to put the burden of local share (given the huge amounts of money) on the backs of small municipalities and taxpayers, given that it is a formula clearly focused on large urban centres; and two, if we are going to contribute financially, we need a say in how that money is being spent
- Having said this, I have yet to find a community in Ontario that was able to "opt out" of the local share
  contribution if a new hospital was being built nearby that was serving citizens in its community one
  way or another, they had to contribute <u>something</u>
- We (ALL of the municipalities impacted by the MAHC build) will continue to lobby for changes in the local share calculations this won't get fixed overnight, but this is a long term horizon of 10-15 years and we are NOT expected to hand over ANY money in the near term
- We need a way forward and the approach put up for discussion yesterday was merely a starting point we are clearly not in position to provide a "solid number" to MAHC by the 15<sup>th</sup> of February or even in
  the next month
- Once again, bear in mind that the numbers presented are viewed as 'worst case' over the next 10-15 years there will be opportunities to fund-raise in different ways, there will be contributions from private citizens and businesses in other parts of the catchment area that will reduce the overall local share needs, there will, hopefully, be movement from the province on what they will contribute, etc.

The proposed jumping-off point in the presentation materials was meant to achieve the following:

- Start discussion amongst all municipalities in the Almaguin Highlands around what is feasible and reasonable for each of them to contribute
- Introduce an approach which gives municipalities in the Almaguin Highlands a level of control over at least some of the healthcare spending in Almaguin (see point 3 above) – the 20% portion of the contribution

Send the message that there are clear limitations on what small communities such as ours can do – an increase in the local share estimates from \$129-m in 2019 to \$225-m today does not mean that we somehow magically have an ability to keep up with increasing costs

I have attached a slightly updated version of the presentation with a correction on the last slide with respect to the Local Share total / max amount. I have also added the note to each slide that these suggestions are "Preliminary – For Discussion Purposes Only".

### **PROPOSED NEXT STEPS**

- Review and discuss with staff and with your councils
- If you need/want further clarification, I am happy to make a delegation to your council...this was the plan originally before the "new deadline" was thrust upon us – I'm just the messenger and my Kevlar vest is at the ready co
- Please consider what your municipality might be capable of contributing and include it in your budget thinking...preferably over the long term of 10-15 years – we're not assuming that "one size fits all" across Almaguin – each of us will have our own reasons and approaches...in other words, PLEASE DON'T GET STUCK ON THE FORMULA!
- Be clear that monies would be set aside in reserve only and, preferably, think in terms of "one reserve" for Local Share (the "80%") and a separate one for healthcare in Almaguin (the "20%")
- I would suggest that we pull in suggestions from each municipality individually and look to re-work our numbers based, again, on what each municipality can reasonably achieve from a funding perspective
- From there, I hope we can meet again and continue discussion

Happy to chat at any time. I am hopeful that we can keep the overall message positive – that is, that we are doing something to support healthcare in the Almaguin Highlands.

### Good day folks and Happy Friday!

I wanted to provide you an update on our MAHC Hospital Local Share discussions and provide an updated overview slide deck with slightly changed numbers. The good news is that we have now included the Township of Georgian Bay to get the full picture, and our overall numbers have dropped slightly. Some points and updates below:

- With the complete numbers, and assuming the same calculation estimate as outlined at our meeting on February 8, 2023, the total Almaguin share (for all 12 municipalities listed) is about \$11.2-million total over the 12 years
- This represents 9.98% of the TOTAL MUNICIPAL SHARE, with the remaining (Muskoka) municipalities sitting at 90.02%
- The slide with the new individual estimates for each Almaguin municipality has been updated accordingly, with a per-year estimate (again, based on 12 years) also shown
- We met with the District of Muskoka on February 13, 2023 and shared our approach, our assumptions and our initial numbers...they felt that this was a rational approach to trying to move this forward, and confirmed that our numbers were accurate (except for the need to add Georgian Bay)...they further expressed that they like the idea of the "Almaguin holdback" and would be taking a similar approach themselves
- The approach was brought to Armour Council on February 14, 2023, and Council agreed to setting aside their portion of the MAHC build and Almaguin healthcare amounts, in reserve, over the next 12 years starting this year (using the numbers from the 8-Feb presentation roughly \$1.2-m for the hospital build and 285k for Almaguin)
- I have had several follow-up discussions with individual Mayors to clarify the information, and have also presented at one other Council meeting (Magnetawan), with others to come
- In order to meet the imposed deadline of February 15, 2023 to provide 'a number' to MAHC, I simply provided a range estimated at "somewhere between \$2-million and \$9.5-million over a 12-year period in total for all Almaguin municipalities" given that Armour has committed about \$1.2-m, I felt the range was reasonable
- The next meeting with the full Local Share Committee is on February 27, 2023...an update will follow

All we can do as individual municipalities is look at our own situations to see what is feasible from a financial perspective – as I said previously, it's not a case where 'one size is going to fit all'. We can only do what we can do. Just to be clear, however, if MAHC is unable to state by the Fall of 2023 that they will be able to meet the Local Share estimate and raise those funds, the hospital build project ends. There are up to 50 other potential hospital builds in the province being considered, and MAHC's would clearly move off the table completely if they can't meet the local share (unlikely to be revisited for many, many years). It's unclear what this would do to the healthcare future in Almaguin, how it would impact our ability to attract healthcare

providers (physicians, nurse practitioners) to our area in future, etc.. There are many potential additional impacts.


# Focus geographic area for MAHC hospital builds



As C.E.O. of *The Friends* organization (<u>www.thefriends.on.ca</u>) I have been keenly aware of the serious shortage of affordable housing in the Districts of Parry Sound Muskoka. In fact, during August and September 2022, when *The Friends* organization was struggling with massive staffing shortfalls we were confounded when Personal Support Workers would have accepted positions but could not find affordable accommodation. Housing shortages affect everyone - whether a retail store, a resort or health care services at the community level.

With this in mind, *The Friends'* is spearheading the development of a Homeshare program across the region (Muskoka/Parry Sound)we serve.

### What is Homesharingsharing?

- Homesharing is a simple idea where two or more people share a home for mutual benefit.
- A person offers a private bedroom and shared common space in exchange for rent, help around the home or a combination of the two.
- It differs from a typical roommate situation because, at its core, it is about two
  people helping each other.
- No two homesharing arrangements are alike. Each is tailored to the unique needs and interests of the people involved.

Homeshare is not the only answer to housing issues, however, if the program can help reduce pressures and support better, more fulfilling outcomes for seniors, then it is worth exploring.
