MINUTES

A Shared Services meeting with the Village of Burk's Falls, Township of Armour and Township of Ryerson was held at the Young at Heart Senior's Centre, 136 Yonge Street, Burk's Falls, Wednesday February 8, 2017 at 6:30 p.m.

Presentation

- 3. Slide presentation (paper) of the Council for the Village of Burk's Falls proposed new cost sharing model for shared services

The slide presentations were read and explained. Reeve Still encouraged each Council member present to read the documents, especially the letter from the Burk's Falls lawyer. She advised that there is significant information in these documents that require more discussion and requested each municipality review them in detail. It was also decided that each municipal Council should provide alternative proposals should they not agree with the information or proposal submitted. Any alternative proposals or suggestions for improvement shall be sent to Burk's Falls prior to the next meeting for inclusion on the agenda.
